**SECTION – I**  
**INSTRUCTION TO BIDDERS AND TERMS & CONDITIONS**

This Section provides instructions to bidders and applicable terms and condition for the Auction.

**1. INTRODUCTION**

1.1 Pakistan Real Estate Investment and Management Company, hereinafter referred to as PRIMACO will receive bids for the auction of various materials as described in Section IV of the Bidding Documents on “AS-IS WHERE-IS, CLEAN-UP, ALL MUST GO” basis.

**2. COST OF BID**

2.1 The Bidder shall bear all costs in the preparation and delivery of their bids and the PRIMACO shall in no case be responsible or liable for such costs, regardless of the outcome of the bidding process.

**3. BID DOCUMENTS**

3.1 A Complete set of Bid Documents shall include:

- 3.1.1. Section I – Instruction to Bidders (IB) and Terms and Conditions;
- 3.1.2. Section II – Eligibility and Qualification Information;
- 3.1.3. Section III – Prescribed Form of Bid (Letter of Offer);
- 3.1.4. Section IV – Exhibit of Materials for Auction and Price Offer;
- 3.1.5. Amendment and/or Addendum on the original bid documents, if any.
- 3.1.6. Special Instructions, if any.

**4. TIME AND PLACE FOR RECEIPT OF THE BIDS**

4.1 Sealed bids will be received at mentioned time and date at PRIMACO, Head Office, 2<sup>nd</sup> Floor, EOBI House, G-10/4, Islamabad, observing subsequent amendment / addendum issued, if any, pertinent thereto at which time all bids shall be opened and read publicly. Submission of bids after the designated time and date shall not be accepted, resultantly rejected.

**5. ELIGIBLE BIDDER**

5.1 A Bidder may be a natural person, private entity, or government-owned enterprise (Government-owned enterprises in the Employer’s country shall be eligible only if they can establish that they (i) are legally and financially autonomous, (ii) operate under commercial law, and (iii) are not a dependent agency of the Employer) or any combination of them with a formal intent to enter into an agreement.

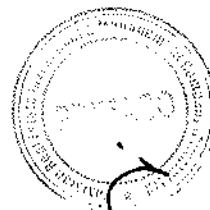
5.2 A Bidder participates in more than one bid in this bidding process will result in the disqualification of all Bids in which it is involved.

**6. BIDS TO BE CONSIDERED**

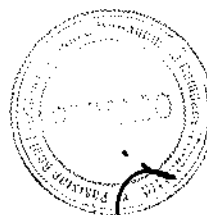
6.1 Only bids from parties and their authorized representatives who have been duly issued/downloaded the Bid Documents shall be opened. Bids from parties who have not been issued the Bid Documents or participated without bidding document fees will be rejected outright.

6.2 The bid, submitted by the parties / companies who have already been declared as Black Listed or whose contract was terminated for dissatisfactory performance in PRIMACO or Government (Federal / Provincial / Local Body) Institute, will not be considered.

6.3 Parties/companies must not be involved in any litigation with the Procuring Agency/Government Department (Provincial/Federal/Local) else their bid will be rejected.



- 6.4 Bids submitted without prescribed Bid Security, or bids submitted with materially defective or otherwise unacceptable Bid Security and bidding document will be rejected outright and returned to the bidder.
7. SUBJECT OF BID
- 7.1 Bids shall be for the auction of the material/items/equipment is stipulated in Section – IV.
- 7.2 The mentioned items/materials shall be sold on an “AS-IS, WHERE-IS, CLEAN- UP, ALL MUST GO” basis.
8. MATERIAL (SUBJECT OF BID) INSPECTION

9. PREPARATION OF BIDS
- 9.1 Bids will be prepared on “Single Stage - One Envelope” basis. All bidders must submit one sealed envelope on or before specified tender opening date/time. Bidders shall prepare their bids using the forms specified in this Bidding Documents and submit sealed bid envelopes which shall be contained the eligibility component of the bid and financial component of the bid.
- 9.2 Eligibility Documents:
- (i) Original Tender Document Fee in form of Pay Order in the name of PRIMACO Islamabad (NTN-2795350-5);
  - (ii) CNIC of the individual,
  - (iii) Complete credentials of the individuals/company with related details,
  - (iv) Valid incorporation/ registration with SECP/GOP/Sole Proprietor,
  - (v) Valid Tax Registration with Tax Department,
  - (vi) An original and valid affidavit on non-judicial stamp paper/e-stamp paper duly verified stating that the individual / firm is not blacklisted by, or having no litigation with, any Govt. / Autonomous Body or between partners.
  - (vii) Duly signed Auction Bidding Documents;
- 9.3 Financial Documents:
- (i) Price Offer/Quotation Form along with Form of Bid; and
  - (ii) Bid Security
- 9.4 Envelope should be securely sealed, signed on the flap and marked as follows:
- (a) Bear the name and address of the Bidder;
  - (b) Bear the specific identification Name and Number of this bidding process; and
  - (c) Bear name and address of the Employer;
  - (d) If envelopes are not sealed and marked as required, the Employer will assume no responsibility for the misplacement or premature opening of the bid.
10. BID CURRENCY
- 10.1 In all bids, prices shall be expressed in written words and figures in Pakistani Rupees. In case of discrepancies between prices in words and figures, the prices in words shall be considered as the bid price.
11. BID RATES AND PRICE(S)
- 11.1 The Prices quoted must be net as per accounting unit as shown in the Section IV, where all duties / taxes and Government levies as applicable at the time of bidding will be borne by the successful bidder. All cost related to stacking, weighing, loading, unloading, transportation etc. shall be borne by the successful bidder.



12. VALIDITY OF THE PROPOSAL

- 12.1 A bid will be deemed valid for a period of Ninety (90) calendar days from the date of bid submission, which shall be stated in the Form of Bid. A bid with a shorter validity period may not be considered subject to the decision of the Employer.
- 12.2 The PRIMACO may, after the expiration of the validity period of a bid, solicit the bidder's consent for an extension of said validity as per Rule 26 of PPRs 2004. The response shall be made in writing.

13. CORRIGENDUM / ADDENDUM

- 13.1 PRIMACO shall reserve the right to amend, revise or modify the Bid Documents prior to the date of opening of bids. Such amendments, revisions, modifications, or clarifications, change of bid submission date if any, will be made through a Corrigendum / Addendum / Addenda, and will be furnished publicly on website for all prospective bidders.
- 13.2 Failure to comply with any amendments / addenda may cause the bid to be considered as not responsive, which could result in the rejection of bid.

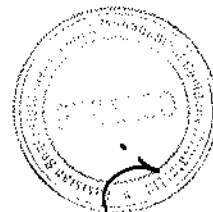
BIDDER'S CLARIFICATION(S)

- 13.3 If any bidder who desires to make any clarifications, on some provisions of the Bid Documents shall communicate such clarifications in writing 5 days prior to opening of bids giving the reasons therefore.
- 13.4 PRIMACO will share responses in writing at least three (3) days prior to deadline for submission of Bids for the general information of all prospective bidders. It shall be the responsibility of all those who have properly secured the Bid Documents to inquire and secure the said clarifications that may be issued by the PRIMACO and uploaded on website.

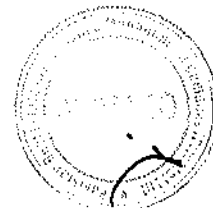
14. BID SECURITY

- 14.1 Each bidder shall submit a Bid Security in the amount as stipulated in the Auction Notice in the form of a Call Deposit / Pay Order / Demand Draft issued by a scheduled bank of Pakistan, in favor of the Pakistan Real Estate Investment & Management Company (Pvt) Ltd, Islamabad or PRIMACO Islamabad.
- 14.2 A bid submitted without the required Bid Security or with a Bid Security in an amount less than the required amount shall be rejected and will be returned to the bidder.
- 14.3 Upon determination of the successful and approved bidder and subsequent acceptance by successful bidder, PRIMACO shall return bid security(ies) of the other bidders subject to decision made by competent forum.
- 14.4 The Bid Security of the successful bidder shall be subject to forfeiture
- a. If the successful bidder fails or refuses to accept the letter of acceptance within five (5) working days after its issuance.
- b. If the successful bidder fails to submit payment in advance within stipulated time period.
- 14.5 The Bid Security of the winning bidder shall be converted into Performance Bond and shall only be refunded after all the awarded items have been completely withdrawn and all provisions of the letter of acceptance have been met by the successful bidder, subject to adjustment/settlement of additional payment in case of quantity of auctioned items increases than estimated quantity (if any) and upon issuance of completion by the Employer.

15. SUBMISSION AND OPENING OF BIDS



- 15.1 Bidders or their authorized representatives may deliver through courier service or by hand their bid on or before mentioned date, time and place. After the time set for bid opening, the bids will be opened and read in the presence of the bidders or their authorized representatives.
- 15.2 Offers submitted after bid submission deadline will not be accepted.
- 15.3 In case of the date of opening of tender declared as Public Holiday by the Government or non-working day due to any reason, the next official working day shall be deemed to be the date for submission and opening of tenders/bids/offers, accordingly. The time and venue shall remain same.
16. ONE BID PER BIDDER
- 16.1 Each bidder shall submit only one bid either by himself, or as a partner in a legal entity. A bidder who submits or participates in more than one bid for the same Lot/Package will be disqualified.
17. DEFECTIVE BIDS
- 17.1 Any Bid found conditional or altered or having any deviation from terms and conditions will be considered as defective and thus rejected.
18. WITHDRAWAL OF BIDS
- 18.1 A bidder may be allowed to withdraw his Bid before the time of opening of bid. Such bid shall be returned unopened.
- 18.2 After the opening of bids has commenced, no bidder shall be allowed to withdraw his offer.
- 18.3 In case any bidder declares in writing for withdrawal of his Bid, its Bid security will be forfeited.
19. EVALUATION AND ACCEPTANCE OF THE BID
- 19.1 The Bids shall be evaluated on the basis of defined criteria and competitive offers. Therefore, all bidders are required to submit bids complete in all respect.
- 19.2 The Bidder whose bid is the HIGHEST, responsive and which is most advantageous to the PRIMACO shall be declared the Successful Bidder.
- 19.3 PRIMACO reserves the right to cancel the process in the event offered price is not corresponding to reserve/base price of item/material.
- 19.4 The Successful Bidder must provide acceptance within five (5) working days from receipt of the written notice from the PRIMACO.
20. FAILURE OF BIDDING
- 20.1 The PRIMACO shall declare the bidding failure in any of the following cases:
- 20.1.1. There is no bidding participant;
- 20.1.2. All bidders failed to comply with the prescribed Terms and Conditions of bidding documents;
- 20.1.3. Complying bidders failed to meet the minimum bid price.
21. AWARD OF CONTRACT
- 21.1 Award shall be made to the HIGHEST COMPLYING bidder.
- 21.2 Contract/Notice of Award/Acceptance Letter shall be issued to the successful bidder after approval of the concerned approving authority.
- 21.3 No transfer and/or assignment of Award/Contract shall be allowed.
- 21.4 The Award shall be cancelled, rendered ineffective and the Bid Security forfeited in favor of the PRIMACO if;



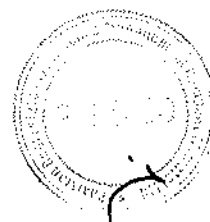
- a) the winning bidder fails to secure, sign or acknowledge the Letter of Acceptance, within five (5) working days after receipt.
- b) the successful bidder failed to deposit bid amount/payment within stipulated time period.

22. PAYMENT

- 22.1 100% of total bid amount should be submitted/deposited, by the successful bidder within seven (7) working days of acknowledgment of Letter of Acceptance, through Call Deposit / Pay Order / Demand Draft issued by a scheduled bank of Pakistan, in favor of the PRIMACO Islamabad (NTN-2795350-5).
- 22.2 No other form of payment shall be accepted.
- 22.3 In case of failure of full payment within the prescribed period, the successful bidder shall be penalized through cancellation of the award and forfeiture of the Bid/Performance Security in favor of PRIMACO.
- 22.4 Pursuant to Clause 21.1, Initial payment made by successful bidder will be subject to actual quantities measured as explained in clause 22.1. In case actual quantity of auction items exceed than estimated quantity as specified in LOA then successful bidder shall have to pay the additional amount immediately for additional quantities so derived. In case actual quantity of auctioned items is found lesser than estimated quantity then the amount of money so derived will be reimbursed to successful bidder as per PRIMACO Accounts department guidelines.

23. RELEASE/WITHDRAWAL OF AWARDED ITEMS

- 23.1 Prior to loading of auctioned items on the vehicle(s), successful bidder has to present certificate of weight of respective vehicle(s) from three (3) different nearby located authorized weighing centers. Once approved by Engineering Department then loading shall be started. Similarly, when respective vehicle(s) is loaded with auction items then certificate of weight of respective vehicle(s) from three (3) different nearby located weighing centers will be secured and Engineering Department will finally sign Release Order with actual quantities of auctioned items. This will apply in case of deformed steel bars or as instructed by employer.
- 23.2 After payment of the awarded items, the successful bidder shall withdraw/take away all the listed items stated in Section IV within the required period as stipulated in the Release Order (RO) by Engineering Department. Otherwise, the successful bidder shall pay the PRIMACO the corresponding storage fee equivalent one percent (1%) per day of the price of the unwithdrawn items, or PKR 2,000.00/day of delay, whichever is higher but not to exceed ten (10%) percent of the total amount of the Award.
- 23.3 Once the cumulative amount of storage fee reaches ten (10%) percent of the total amount of Award, the PRIMACO may rescind/cancel the Award, forfeit the Bid Security, and impose the appropriate sanctions as penalty.
- 23.4 The actual release/withdrawal of awarded items shall made within seven (07) working days, during regular office hours, Monday through Friday, and shall be monitored by the designated representative(s) of the Employer.
- 23.5 Selective withdrawal is not allowed. The successful bidder shall withdraw all the items.
- 23.6 The Employer is held harmless from any/all claims and losses acquiring from or resulting to any/all bidders, materials, labor, and any other person. In connection with the performance of this public auction, bidders must accept all responsibility for being aware of which items are available and their current condition.





24. TAXES, CUSTOMS DUTIES, COST OR CHARGES

- 24.1 The successful bidder shall be liable for prevailing taxes, customs duties, costs of charges of any kind or nature whatsoever levied, or levied by law, arising from the auction of items.  
24.2 All expenses incidental to the withdrawal of the items shall be borne by the successful bidder.

25. DISPUTE RESOLUTION AND ARBITRATION

- 25.1 In the event of any claim or dispute arising out and the Contractor is dissatisfied with any decision of the Employer's Representative, after appealing to the Grievance Redressal Committee of PRIMACO, if dispute remains unresolved, the matter shall be finally settled as per provisions of Arbitration Act 1940 (Act No. X of 1940) and Rules made there under and any statutory modifications thereto. Venue of Arbitration will be Islamabad.

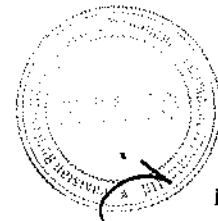

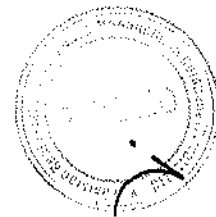

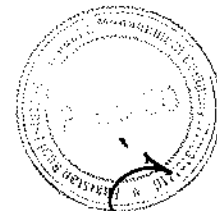
